### DECISION

Pursuant to Article 155 and Article 104 of the Act of 14 June 1960 on the Code of Administrative Proceedings (the harmonised text in the Journal of Laws from 2013, Item 267), in relation to Article 378(2a) of the Act of 27 April 2001 on the Environmental Protection Law (Journal of Laws from 2013, No. 25, Item 1232 as amended) and having examined the application filed by Mr Michał Okonowicz, representing P.P.H.U. 'DUOMAT 2' Okonowicz Michał with its registered office in Recz, for an amendment to the permit to produce waste taking into account the activity in processing hazardous and other waste in relation to the operation of the Waste of Electrical and Electronic Equipment Processing Plant in Choszczno, 29F Dąbrowszczaków street

#### I hereby decide as follows:

**to amend** the decision of the Marshal of Zachodniopomorskie Voivodeship of 31 July 2013, ref. No. WOŚ.II.7243.3.3.2013.IB, amended with the decision of the Marshal of Zachodniopomorskie Voivodeship of 30 September 2013, ref. No. WOŚ.II.7243.8.3.2013.IB and the decision of 9 April 2014 ref. No. WOŚ.II.7243.6.1.2014.IB as follows:

4. Section 6a of the above-mentioned decision to read as follows:



To indicate the sites of collecting waste:

- a. Processing Plant of Equipment Waste – ul. Dąbrowszczaków 29F (plot No. 69/100, precinct 4). Waste shall be collected at points allocated in the service-production-warehouse hall with tight, hardened surface, roofed and protected against access of third parties. Next, after weighing and the preliminary segregation, waste shall be transferred for further storage at the warehouse of waste being a part of the plant.
- b. Service Point – ul. Dąbrowszczaków 29F (plot No. 69/100, precinct 4). Waste shall be collected at points allocated in the service-production-warehouse hall with tight, hardened surface, roofed and protected against access of third parties. Next, after weighing and the preliminary segregation, waste shall be transferred to the Waste of Electrical and Electronic Equipment Processing Plant.
5. All other terms and conditions of the Decision of the Marshal of Zachodniopomorskie Voivodeship of 31 July 2013, Ref. No. WOŚ.II.7243.3.3.2013.IB including the amendment of 30 September 2013, Ref. No. WOŚ.II.7243.8.3.2013.IB and the amendment of 9 April 2014 ref. No. WOŚ.II.7243.6.1.2014.IB **shall remain unchanged.**

### Justification

This Decision has been issued under applicable regulations mentioned in the preamble and upon the analysis of the application filed by Mr Michał Okonowicz, running his business activity under the firm: Przedsiębiorstwo Produkcyjno-Handlowe 'DUOMAT 2' with its registered office in Recz, 9 Chyża street, for amending a permit for processing waste taking into account the activity in processing and collecting hazardous and other waste in relation to the operation of the Waste of Electrical and Electronic Equipment Processing Plant in Choszczno, 29F Dąbrowszczaków street.

According to the submitted application, the amendment concerns the extension and detailing of the said permit with regard to the scope of collecting waste within the Waste Processing Plant and the Service Point at the above-mentioned location.

During the procedure, the investor supplemented the application with the letter on 13 April 2015 in response to the request of 26 March 2015, Ref. No. WOŚ.II.7243.3.1.2015.IB.

Recognising the submitted application as the grounds for issuing this decision and that any and all work related to waste management shall be carried out in compliance with applicable regulations in this respect and that all the terms and conditions hereof shall be fulfilled, **the decision has been taken as given in the preamble hereto.**

This Decision may be appealed against to the Minister of the Environment via the Marshal of Zachodniopomorskie Voivodeship within 14 days of the receipt hereof.
